# City of Seneca Council Meeting Minutes October 14, 2024

Council meeting was called to order at 6:00 p.m., Monday, October 14, 2024, at City Hall by Mayor Brad Storrs. Members present: Ryan Schauer, Jamie Lankford, Sheila Whitehead, Skyler Jones and Derinda Malone.

#### **DEPARTMENTS:**

**Police Department:** 

Police Chief Altic reported Shop With A Cop is scheduled for Saturday, December 7, 2024 at 7:00 a.m. at the 15th Street Walmart. He said they will be working with Eremish and Bright Futures.

Police Chief Altic reported he met with Senator Carter. He added a meeting was held to discuss the immigration issue. Police Chief Altic reviewed a situation with a DWI arrest and an interpreter had to be provided, a medical assessment had to be completed to return the individual back to Newton County with a court date scheduled several years out. He added the Task Force is meeting to review the problems such as the individuals have no driver's license or proof of residency.

Police Chief Altic reported due to school threats and issues they have purchased camera detectors for the SRO's.

Police Chief Altic reported the fleet of patrol cars has had 7 alternators replaced and 3 vehicles with frontend recall repairs.

Police Chief Altic reported Seneca's Homecoming Week was busy and the parade was the longest ever. He thanked Public Works and the firemen for helping with traffic control.

Police Chief Altic said everything is going ok and they are preparing to shut down the budget for yearend.

Mayor Brad Storrs stated he attended a Town Hall Meeting in Joplin recently. He said Police Chief Pearson discussed Haitian immigrants being housed at Crowder in Neosho. He added concerns are recourse if we don't have the resources to handle the individuals. Police Chief Altic said they can anticipate 200 to 250 children placed in the public school systems. Mayor B. Storrs encouraged everyone to reach out to our state representatives to voice how you feel regarding concerns and/or support of the situation.

# Reinstated Motion - August 12, 2024:

A motion was made to have the City Attorney provide a letter to Lost Creek Wireless, LLC, Clayton Driskell allowing him 5 business days to contact Liberty Electric and confirm his request for an electric service meter with 30 calendar days to have his new electric meter/service installed for the Lost Creek Wireless equipment instead of the City's service meter at the Well sites and if the requirements are not met, the City of Seneca will revoke the Business License for Lost Creek Wireless, LLC by D. Malone, yea; motion carried.

# Rescinded Motion - September 9, 2024:

A motion was made to have Clayton Driskell on behalf of Lost Creek Wireless, LLC bring a contract/lease agreement to the City of Seneca for the use of electricity at the city water tower including: an indemnity clause, entire meter at his expense, any additional equipment added must be approved by the City of Seneca and the monthly fee will be a meter fee of \$35 plus \$10 a month electricity paid to the City of Seneca by S. Whitehead; seconded by S. Jones. All members voted yea; motion carried.
